*Mrs. Morton: [takes phone] You can get it after school from Mr. Badogan!

*Kathryn: Wait, I didn't set the password. Hey, you all can't take it! This is not fair!

Mrs. Morton takes the phone to the Dean's office.

Setting: Mr. Badogan's office

Mr. Badogan sits down to have his lunch. He notices a text message come in. The text message says: "Hey, what's up bae! I got some stuff for you!"

***Mr. Badogan:** What's this!? "Hey what's up bae! I got some stuff! Someone is bringing drugs to school! I can see from this message that someone has drugs in the school! Someone call Mrs. Baxey and Officer Belias
